Refers to the total assessment for a municipality weighted by the tax ratio for each class of **B2** property (including payments in lieu of property taxes retained by the municipality) divided by the total number of households Represents the proportion of a municipality's population residing in rural areas and/or small **B3** communities. A lower MFCI corresponds to relatively **B5** positive fiscal circumstances, whereas a higher MFCI corresponds to more challenging fiscal circumstances.
