That part of the King's Highway known as No. 12 in the Town of Whitby in The Regional Municipality of Durham lying between a point situate at its intersection with the centre line of the roadway known as Garden Street and a point situate 570 metres measured southerly from its intersection with the centre line of the King's Highway known as No. 7.

**(2) Part 4 of Schedule 16 to the Regulation is amended by adding the following paragraph:****Regional Municipality of Durham — Town of Whitby**

That part of the King's Highway known as No. 71 in the Township of Claxton in the Territorial District of Rainy River lying between a point situate 1250 metres measured southerly from its intersection with the roadway known as Dock Road in the locality known as Nestor Falls and a point situate 500 metres measured northerly from its intersection with the roadway known as Airport Road/Sabaskong Bay Road in the locality of Nestor Falls in the Township of Godson in the Territorial District of Kenora.
